# **Church Reopening Guidelines**

The Session of the First Presbyterian Church of Westerville is continuing to shepherd this church through the trials caused by this pandemic. It is a challenging task, with many factors to consider. The Session has made its decisions prayerfully and deliberately, seeking always to be faithful to God in the process. The elders have sought to find new and creative ways to do worship, education, fellowship, and mission in a world where a potentially deadly disease can easily spread. The Session is continually seeking guidance from the congregation; from the experts in the field; from national, state, and local authorities; and from our denomination. Below is the latest guidance from the Presbytery:

From the Presbytery of Scioto Valley

September 10, 2020

Dear Friends,

"I was glad when they said to me, "Let us go to the house of the LORD!" Psalm 122:1 NRSV

We continue to keep you all in our thoughts and prayers as we journey through this pandemic time. As we continue to hear from you requesting guidance about returning to in-person worship, here is our best guidance for you at this time.

Utilize the Public Emergency Color Coded System instituted by the State of Ohio to make decisions about indoor in-person worship.

*If your county is under Public Emergency Level 3 (red)*, the *c*hurch building should remain closed for all activities, including no in person Sunday services.

If your county is under Public Emergency Level 2 (orange), the church building should remain closed to indoor Sunday services. Essential service will continue. Outside use requests should be approved or denied at the discretion of the Session based on each request's ability to adhere to public health mandates and to mitigate any potential danger to the community. As always, Session reserves the right to withdraw usage permission if local conditions warrant. Additionally, individuals should consider avoiding contact with anyone who is considered high-risk. High-risk individuals should take extra care to follow precautions, and decrease in-person interactions outside their household.

If your county is under Public Emergency Level 1 (yellow), the church building may be reopened for in person Sunday services. Outside use requests should be approved or denied at the discretion of the Session based on each request's ability to adhere to public health mandates and to mitigate any potential danger to the community. For those who have resumed in person worship within their church building, we urge you to use every precaution and to following safety protocols diligently so that no members will become infected with COVID-19.

# As your congregation resumes indoor worship, we urge you to use every precaution and to follow safety protocols diligently.

A good starting point would be the previous guidance released by the presbytery from the current stated clerk, Jim Wilson: (a complete listing is in the "Guidance to congregations considering reopening" found on the PSV website.)

• Masks for all individuals over 10, covering mouths and noses, are mandatory as of 7/22/20. Any person failing to wear a mask <u>must</u> be asked to leave immediately. If the individual refuses, the worship or activity <u>must</u> be terminated immediately. We understand that for some individuals, wearing a mask is a political issue. This will not protect you from liability if someone contracts Covid-19.



- Attendance should be taken at all meetings in the church, including worship, and contact information obtained for each person in attendance in the event it is necessary to contact attendees regarding possible exposure to Covid-19.
- Physical distancing is mandatory, even with masks. Six feet is a minimum, not a guideline. Like masks, if individuals refuse to comply, the person must leave or the activity must immediately be terminated.
- All participants should affirm the following before being permitted to enter worship or a church activity
  - The individual has taken his or her temperature shortly before arriving at the church and his or her temperature is below 100.4 F.
  - The individual is not experiencing any symptoms associated with COVID-19, such as fever, chills, cough, shortness of breath, sore throat, new loss of smell or taste, diarrhea, or vomiting.
  - The individual has not previously been diagnosed with, or suspected to have, COVID-19 and has been completely symptom free for at least 72 hours without any medication.
  - The individual has not been exposed within the past 14 days to anyone diagnosed with, or suspected to have, COVID-19.

- The individual has not traveled within the past 14 days either internationally or to any domestic location outside of Ohio.
- In enforcing these requirements, we urge that niceness not be confused with kindness—kindness is protecting the vulnerable in these circumstances.

- Singing is <u>strongly</u> discouraged as a high-risk activity.
- Celebration of the Lord's Supper is also a <u>high-risk</u> activity unless means can be devised to maintain physical distancing and to ensure the elements are free from any risk of transmitting the Covid-19 virus.

Respect each other in our own personal decisions as well as our pastors who might feel uncomfortable due to health issues.

While many insurance companies did not initially have any requirements of churches prior to the return to in-person/in building worship, many have begun to require waivers related to COVID-19. Sessions should check with their insurance companies regularly to make sure the requirements remain the same.

The Coordinating Team strongly suggests the guidelines above, according to the state level system.

Siblings in Christ, we know that the longer the difficult situation with COVID-19 is prolonged, the more anxiety-provoking ministry can become. However, even now, we have renewed opportunities to learn how to faithfully care for one another, recognizing that each of us will approach the weeks and months ahead differently. Though this is new to us, leaning on Christ to lead us through difficult situations is not new to us. Being the Church no matter what comes our way is not new. Please know that we will continue to support you in every way we are able. Thank you for your faithfulness and perseverance.

With Franklin County currently coded orange, our Session has decided not to consider resuming inperson worship before Nov. 1. At its October meeting, the Session will consider the current coding status of Franklin County and decide our next steps. We ask that you keep our Session and our church in your prayers as we continue on this journey together.

A Reminder: We are continuing to livestream our worship service at 10:15 a.m. every Sunday. An easy way to access this service is to go to the church's website (<a href="www.westervillefirstpresbyterian.org">www.westervillefirstpresbyterian.org</a>). Click on "virtual services" in the left column. On the next screen, click on the word "HERE" at the end of the first paragraph. That will take you to our Facebook page. You can also access recordings of previous services there. An audio recording of the worship service is placed on our website shortly after each service, and Rev. Gauen's sermon is sent in the daily emails on the following Tuesday.

## **World Communion Sunday** October 4

October 4, the first Sunday in October, is World Communion Sunday. We will be celebrating a virtual communion on that day for those who attend the service virtually and for those who watch it taped later in the week on Facebook or listen to it from our website. I will do the communion liturgy from the sanctuary, and all who want to participate can do so from their homes. At-home participants will need to get their own grape juice or wine and piece of bread or cracker. Obviously, this is different from how we usually experience communion, but in this covid world, the symbolism of Christians around the world joining at Christ's table will be a powerful statement. This form of communion is also in line with guidance from the denomination (see below). I hope you will join in.

The Latin phrase *per capita* means "per person." Per capita is the donation our church makes annually to help support the Presbytery of Scioto Valley and the Presbyterian Church USA. This year, the per capita donation is **Thanks** \$37.75 per person. Here's how this essential donation helps:

for Your Support!Per Capita connects Presbyterian Church (U.S.A.) congregations and mid councils with the work of the wider church. As the primary source of funding for the Office of the General Assembly (OGA), it is how Presbyterians mutually and equitably share the costs of moving the

church forward in the 21st century. Per Capita giving makes it possible for:

- Presbyterians to discern and live out God's call in their lives
- Churches to connect with individuals seeking a call to ministry
- OGA to staff and support General Assembly committees and commissions

- OGA to manage and coordinate General Assembly gatherings
- Presbytery and synod leaders to gather for training and discernment
- OGA to provide counsel and support for churches in crisis (misconduct, legal matters)
- Presbyteries to address matters of inclusion, participation and representation at all levels of church leadership and decision making
- The denomination to build connections with ecumenical partners around the world
- Presbyteries and pastors to receive support on immigration issues
- Presbyterian history to be saved and utilized by future generations

All Presbyterians are called to take part in the whole church's ecclesiastical and administrative work through per capita giving. The annual rate is a per-member apportionment that is assessed biennially by the General Assembly. (Book of Order, G-3.0106)










### **Sanctuary Flowers**





# **Pastor's Page**

Dear Friends:

This past summer, the Presbyterian General Assembly, our denomination's national meeting, set aside Sunday, October 25, as a day of prayer focused on the pandemic: "We call on our whole church to commit to continuous discernment of how to meet the social justice, economic, and spiritual challenges of the pandemic. We set aside Sunday, October 25, 2020, Reformation Sunday, as a day of prayer for responding to those challenges."

All of us, as Presbyterians, are encouraged to take some time on that day to offer prayers to God, praying for the welfare of those who have the disease, for the comfort of those who have lost someone to the disease, for those who are actively fighting the disease, for those whose jobs continue to put them at higher risk in catching the disease, for those who are isolated by the disease, for those who have suffered from the economic fallout of the disease, for our world's leaders who continue to make decisions regarding the disease, and for all of us who are just plain tired of the disease.

To help you, here is a prayer that you can pray on Reformation Sunday, October 25. It was shared at General Assembly by the outgoing moderators, Vilmarie Cintrón-Olivieri and the Rev. Cindy Kohlmann.

Eternal God, sustainer, provider, God of all wisdom and knowledge,

Our spirits are weary, our faith quivers, our minds get clouded by news of sickness and death. You know our thoughts before we express them, even the fears we dismiss, you know them. We cannot hide our feelings and worries from you.

So, as we are, we come to You, O God, asking for wisdom, for clear minds and open hearts, for calm

and assurance that, through the crisis, You are present.

Knowing that "the Spirit helps us in our weakness; for we do not know how to pray as we ought, but that very Spirit intercedes with sighs too deep for words,"

We ask for wisdom and protection...

For medical personnel, scientists, doctors, nurses, and laboratory technicians.

For those around the world considering current and other health crises.

For health care personnel and caregivers.

We lift them up to You. Bendíceles con sabiduría; protégeles de todo mal.

We ask for clear minds and open hearts as people navigate daily lives...

As closures, cancellations, and guarantines are enacted.

As families gather in their homes, some caring for those who are sick.
